This document covers finPOWER Connect information for InfoAgent.

SUMMARY

InfoAgent is a Security Enquiry provider, providing information on Vehicles or anything that has a Registration Plate. They also provide a Credit Enquiry option to be able to do a search on Client Driver's Licences in New Zealand.

InfoAgent options are available in both New Zealand and Australian databases.



 - **Define the API Credentials** - enter the **Client Id** as provided by InfoAgent and the encrypted **Client Secret** key.
5. Click the **Save** button. Once saved, you can click the Verify button to check the 'Service Status' and that the information entered is correct.



The Options tab is where you **Enable** the options required.

1. **Credit Enquiry Options** – This option allows you to do a Driver Licence Check (New Zealand only) for the Client.
2. **Security Enquiry Options:**
 - Tick the **Enable Security Enquiry** checkbox.
 - Tick the **Enable Security Monitoring** checkbox if required.
3. **Security Enquiry Defaults** – Select the 'Default Product'. The reports are in order of complexity, for example the Basic report will include Plate, VIN, Chassis etc., whereas the 'Comprehensive Report Plus' includes everything that InfoAgent can provide.

INFOAGENT MONITORING

Monitoring functionality has been added to the InfoAgent Security Enquiry service.

This allows you to send details of Motor Vehicles you want InfoAgent to monitor; for things such as plate changes, ownership changes, reported stolen and deregistered/written off. Alerts will be emailed to the address stored in the InfoAgent Account.

ACCESSING MONITORING OPTIONS – SECURITY STATEMENT ITEM

finPOWER Connect includes options to start and stop monitoring vehicles, as well as holding vehicles from being monitored by InfoAgent.

On the Security Statement form, Security Items page, the summary page includes the section **Monitoring** which contains the following buttons:
